All prices are subject to change. Lapeer Pilot Center, LLC, will give advance notice of any rate changes. Payment is required for all services rendered, including introductory flights. All flight training fees must either be paid upon receipt or deducted from student accounts.

COURSE COMPLETION

The hours specified in each Program or Course fulfill the minimum FAR Part 61 requirements. However, it should be noted that not all students are able to learn to fly an airplane well enough to meet the FAA practical test standards in the minimum times listed, and it should not be considered unusual if they are exceeded by as much as 15 hours or more. Good study habits, personal discipline and aptitude are all necessary ingredients for successful completion of all Programs and Courses.

Rental of the airplanes for the practical test is required. The rental rates vary depending upon the airplane used. The practical test normally takes between one and two hours.

CANCELLATION POLICY

If you are late more than 30 minutes or don't show up at all for a scheduled lesson, you will be charged a no-show fee as set forth in Lapeer Pilot Center's Standard Operating Procedures. Lapeer Pilot Center requires 24 hours advance notice to cancel a scheduled lesson or a booking for a solo rental.

PAYMENT METHOD

Lapeer Pilot Center allows you to pay as you go or place money on account with LPC. Payment must be in cash or by accepted charge card unless prior arrangements have been made. Lapeer Pilot Center will charge the pro rata hourly rate for each tenth of an hour of flight or ground instruction received, and for solo aircraft rental.

CERTIFICATES ISSUED

Upon completion of each individual course or program, you will receive a graduation certificate from Lapeer Pilot Center. Upon successful completion of the FAA practical test you will receive the appropriate FAA certificate or rating.

REFUND POLICY

You are entitled to a full refund of the unused portion of your flight account balance at any time for any reason. Refunds will normally be issued within 30 days but may be delayed until your check has cleared. Student account balances obtained from education loans will be refunded to the lending institution as required at the completion of training. All book purchases are final and nonrefundable.

SCHOOL HOURS AND ATTENDANCE

Lapeer Pilot Center is open seven days per week, from 8:00AM to 6:00PM in the summer and 9:00AM to 5:00PM in the winter. After-hours lessons and night flights can be scheduled by arrangement with your instructor. We are closed on major holidays; however, training/rentals can be arranged on a case by case basis. Program and Course starting dates will be arranged on a date convenient to the student and the school after receipt of this enrollment agreement.

STUDENT APPEARANCE

For safety reasons, you are not permitted to wear open-toed shoes. Since flight instruction takes place within the confines of a small airplane, you should maintain acceptable standards of personal hygiene.

DISENROLLMENT POLICY

If you violate any of Lapeer Pilot Center's rule and regulations, you will be placed on probation for a period of four weeks. If you continue to violate Lapeer Pilot Center's rules and regulations, you will be disenrolled from the school.

PROGRAM CHANGES

Lapeer Pilot Center reserves the right to change or modify the contents of any of the individual courses, and to change or modify equipment, staff and/or materials used. In some cases, changes may be mandated by FAA regulations. In other cases, changes or modification may be necessary to improve teaching methods or to keep pace with technological advances.
